Khyber Pakhtunkhwa Information Technology Board (KPITB) is a public sector autonomous body of the Government of Khyber Pakhtunkhwa, Pakistan.

KPITB is undertaking a project titled “Digital Jobs in Khyber Pakhtunkhwa” for promoting Business Process Outsourcing (BPO) industry in Khyber Pakhtunkhwa. The project is funded through a grant by the Multi Donor Trust Fund (MDTF), administered through the World Bank.

Under the ‘Digital Jobs in Khyber Pakhtunkhwa’, KPITB invites Request for Expression of Interest (REOI) from well-established national and international consultancy firms/enterprises (“The Consultant”), offering **Business Process Outsourcing Work Platform** to support the program through Online Outsourcing. KPITB may facilitate in providing: (i) furnished and connected workspaces for conducting trainings; and (ii) necessary financing required to run the program. In exchange the selected consultant shall: (i) establish a dedicated online platform for outsourcing, (ii) create demand for generating up to 500 full-time online work opportunities for KP residents, (iii) provide essential skills training, certifications (where required) and on-boarding of online workers on to the platform. The contract shall be for a period of (01) one year. The program is expected to promote job creation, capacity building and the expansion of digital skills to the disadvantaged communities in the province of Khyber Pakhtunkhwa and is expected to remain self-sustainable in the subsequent years.
